The Meeting was chaired by **Mr. Amjid Hussain Sheikh, Chairman PGMEA** and was commenced with the **recitation of Holy Quran by Syed Shahzada Ibn-e-Ahmed Iqbal, Former Chairman PGMEA.** The attendees were welcomed by the chair person.

The Agenda Items were referred to the House in its sequence as such:-

1- Fateha Khawani for:

Mother-in-Law of Chaudhery Muhammad Ijaz Former Sr. Vice Chairman PGMEA and Partner of M/s: SZCO Mfg. Co and Mother of Mr. Waseem Naeem, Mr. Anjum Naeem and Mr. Nadeem Naeem of Jingle Bell School.

2- Leave Application(s):-

The leave application requests were considered by the House and approved unanimously.

3- To approve the Minutes of Executive Committee Meeting held on 26-04-2022:-

Mr. Amjid Hussain Sheikh, Chairman PGMEA requested the House to review and consider the enclosed subject Minutes of Meeting in context to its proceedings by recollecting the discussion and importantly exchange of views by the attendees during the Meeting. The Chairman also requested for any remarks before final approval.

Mr. Muhammad Sarwar, Former Chairman PGMEA stated that we should write a letter to the Director TDAP, Sialkot to give subsidy on International Exhibition A+A, Dusseldorf Germany. Also, he suggested taking quotation of solar energy system for Pakistan Gloves Manufacturers & Exporters Association.

Mr. Sohail Masood, Former Chairman PGMEA said we will need about 10KVA solar energy system to install in Pakistan Gloves Manufacturers & Exports Association.

Mr. Sadaqat Ali Khan, Former Chairman PGMEA apprised that 12 KVA Solar System will be enough for Pakistan Gloves Manufacturers & Exports Association. It will supply Non Stop Electricity.

Haji Aftab Ahmed Barlas, Founder Chairman PGMEA apprised that when **Mr. Muhammad Sarwar** was a Chairman of Pakistan Gloves Manufacturers & Exports Association session 2018-2019 we had taken quotation of Solar Energy System but the members of the Executive Committee of PGMEA rejected Solar System installation. Therefore, a 70 KV generator was then installed in the Pakistan Gloves Manufacturers & Exporters Association at a cost of PKR. 1.3 million.

Considering the Minutes satisfactorily the House unanimously approved the Minutes of Meeting.

4- To approve the Income / Expenditure of Accounts April 2022:-

The Monthly statement of Account for the Month of April 2022 was referred to the House with its entire detail summary. The Chairman requested for any comments / clarifications.

The House checked statement of Accounts and after having satisfaction unanimously approved the subject income/expenditure statement of Account for Month April 2022.

6- Approval of New Membership:-

7- **Any other matter:-**

Syed Shahzada Ibn-e-Ahmed Iqbal, Former Chairman PGMEA apprised the House about the big shortage of split leather in the country. He said that Afghanistan and Iran are the major suppliers of our leather. But in these days the leather is not coming from those countries, they suggested that we should re-engage with leather suppliers in these countries.

Mr. Muhammad Sarwar, Former Chairman PGMEA said that we should increase the sources of our suppliers and share our resources with each other because we cannot import leather at a higher price. Also they suggested that we should send a letter to the Ministry of Commerce and apprised the shortage of leather in the country. We should import leather from Afghanistan and Iran. In fact, Footwear export has enhanced 20% from Pakistan.

Mr. Asad Naseer Malik, Former Chairman PGMEA suggested that R&D Department of Pakistan Gloves Manufacturers & Exporters Association should work, search and check the challenge. We should involve university students in research so that they can do research on the Leather shortage problem. In addition, we should work with the Pakistan Leather Garment Manufacturers and Exporters Association (PLGMEA) to address this shortfall.

Mr. Irfan Ahmed, Vice Chairman PGMEA apprised that from Sialkot to Karachi there is a Leather shortage issue. We should import leather from Afghanistan and Iran.

Mr. Amjid Hussain Sheikh, Chairman PGMEA endorsed that to write a letter to Syed Naveed Qamar, Federal Minister of Commerce and Investment and Mr. Muhammad Sualeh Ahmed Faruqui, Federal Secretary Commerce regarding shortage of leather from Pakistan. Government of Pakistan should solve this issue and import leather from Afghanistan and Iran.

The Chairman told that Mr. Badar Shakil, Computer Operator's has Son's School and Daughter's Collage fee problem. They have requested to PGMEA to facilitate him to pay Children Fee.
