10-	Shall submit nomination papers for vacant posts for eligible members to contest duly proposed, seconded and signed by candidate to Secretary General.	=	<u>22-08-2015</u> Saturday
11-	Shall Exhibit list of nomination papers giving name of candidate, proposer and seconder after proper scrutiny by Election Commission on notice Board-Website and to D.G.T.O. / Regulator	=	<u>24-08-2015</u> Monday
12-	Shall delivery Final List of voters to contesting candidate.	=	<u>24-08-2015</u> Monday
13-	Any objection to nomination of candidate to be filed with Election Commission if any.....	=	<u>26-08-2015</u> Wednesday
14-	Decision by Election Commission on nomination objection.	=	<u>27-08-2015</u> Thursday

15-	In case of Election Commission decision negative or otherwise, or any delay, the aggrieved candidate may file appeal with D.G.T.O. / Regulator if any.....	=	<u>01-09-2015</u> Tuesday
16-	Final Decision by D.G.T.O. / Regulator on nomination objection by aggrieved candidates.	=	<u>05-09-2015</u> Saturday
17-	Final List of contesting candidates after decision of D.G.T.O. / Regulator to be exhibited on notice board – website.	=	<u>07-09-2015</u> Monday
18-	Withdrawal of candidature may be done by notifying in writing to Election Commission.	=	<u>10-09-2015</u> Thursday
19-	After considering withdrawal or otherwise, if the members of validly nominated candidate be equal to the vacant posts , the Election Commission on the report of Polling Officer (Election Commission) will declare provisionally such candidates to have been elected unanimously/ unopposed.	=	<u>10-09-2015</u> Thursday
20-	Contesting candidate may appoint a Polling Agent each by delivering a letter of appointment to the Election Commission.	=	<u>12-09-2015</u> Saturday
21-	Polling of votes shall be conducted in Association Registered Office from 9.00 A.M. to 4.00 P.M. without break to elect members of Executive Committee by Corporate and Associate Members.	=	<u>12-09-2015</u> Saturday
22-	Counting of votes shall take place immediately after the polling hours under the supervision of Polling Officer (Election Commission) and in the presence of the desiring candidates and / or their Polling Agent if any at the designated site.	=	<u>12-09-2015</u> Saturday
23-	Provisional results may be declared by the Election Commission immediately after the counting of votes is completed.	=	<u>12-09-2015</u> Saturday
24-	The Election Commission shall communicate in writing the result of election to the successful candidates and a copy thereof will be provided to the Secretary General.	=	<u>14-09-2015</u> Monday
25-	The Secretary General will convene the first Meeting within Two days of newly elected Members of the Executive Committee for Election of the Office Bearers.	=	<u>15-09-2015</u> Tuesday
26-	The First Meeting of newly Elected Executive Members will be held at 03:00 P.M. at Association Office for the election of following office Bearer.
