12-	Shall delivery <u>Final List</u> of voters to contesting candidate.	=	<u>22-08-2023</u> Tuesday
13-	Any objection to nomination of candidate to be filed with Election Commission if any.....	=	<u>25-08-2023</u> Friday
14-	Decision by Election Commission on nomination objection.	=	<u>28-08-2023</u> Monday

15-	In case of Election Commission decision negative or otherwise, or any delay, the aggrieved candidate may file appeal with D.G.T.O. / Regulator if any.....	=	<u>31-08-2023</u> Thursday
16-	<b>Final Decision</b> by D.G.T.O. / Regulator on nomination objection by aggrieved candidates.	=	<u>06-09-2023</u> Wednesday
17-	<b>Final List of contesting candidates</b> after decision of D.G.T.O. / Regulator to be exhibited on notice board – website.	=	<u>07-09-2023</u> Thursday

20-	Contesting candidate <b>may appoint a Polling Agent</b> each by delivering a letter of appointment to the Election Commission.	=	<u>13-09-2023</u> Wednesday
21-	Polling of votes shall be conducted in Association Registered Office from 9.00 A.M. to 4.00 P.M. without break to elect members of Executive Committee by Corporate and Associate Members.	=	<u>13-09-2023</u> Wednesday
22-	Counting of votes shall take place immediately after the polling hours under the supervision of Polling Officer ( <b>Election Commission</b> ) and in the presence of the desiring candidates and / or their Polling Agent if any at the designated site.	=	<u>13-09-2023</u> Wednesday
23-	Provisional results may be declared by the <b>Election Commission</b> immediately after the counting of votes is completed.	=	<u>13-09-2023</u> Wednesday
24-	The <b>Election Commission</b> shall communicate in writing the result of election to the successful candidates and a copy thereof will be provided to the Secretary General.	=	<u>14-09-2023</u> Thursday
