21-	Polling of votes shall be conducted in Association Registered Office from 9.00 A.M. to 4.00 P.M. without break to elect members of Executive Committee by Corporate and Associate Members.	=	<u>14-09-2024</u> Saturday
22-	Counting of votes shall take place immediately after the polling hours under the supervision of Polling Officer (Election Commission) and in the presence of the desiring candidates and / or their Polling Agent if any at the designated site.	=	<u>14-09-2024</u> Saturday
23-	Provisional results may be declared by the Election Commission immediately after the counting of votes is completed.	=	<u>14-09-2024</u> Saturday
24-	The Election Commission shall communicate in writing the result of election to the successful candidates and a copy thereof will be provided to the Secretary General.	=	<u>17-09-2024</u> Tuesday
