11-	Shall <u>Exhibit</u> list of nomination papers giving name of candidate, proposer and seconder after proper scrutiny by Election Commission on notice Board-Website and to D.G.T.O. / Regulator	=	<u>24-08-2021</u> Tuesday
12-	Shall delivery <u>Final List</u> of voters to contesting candidate.	=	<u>24-08-2021</u> Tuesday
13-	Any objection to nomination of candidate to be filed with Election Commission if any.....	=	<u>27-08-2021</u> Friday
14-	Decision by Election Commission on nomination objection.	=	<u>30-08-2021</u> Monday

15-	In case of Election Commission decision negative or otherwise, or any delay, the aggrieved candidate may file appeal with D.G.T.O. / Regulator if any.....	=	<u>02-09-2021</u> Thursday
16-	Final Decision by D.G.T.O. / Regulator on nomination objection by aggrieved candidates.	=	<u>08-09-2021</u> Wednesday

20-	Contesting candidate may appoint a Polling Agent each by delivering a letter of appointment to the Election Commission.	=	<u>15-09-2021</u> Wednesday
21-	Polling of votes shall be conducted in Association Registered Office from 9.00 A.M. to 4.00 P.M. without break to elect members of Executive Committee by Corporate and Associate Members.	=	<u>15-09-2021</u> Wednesday
22-	Counting of votes shall take place immediately after the polling hours under the supervision of Polling Officer (Election Commission) and in the presence of the desiring candidates and / or their Polling Agent if any at the designated site.	=	<u>15-09-2021</u> Wednesday
23-	Provisional results may be declared by the Election Commission immediately after the counting of votes is completed.	=	<u>15-09-2021</u> Wednesday
24-	The Election Commission shall communicate in writing the result of election to the successful candidates and a copy thereof will be provided to the Secretary General.	=	<u>16-09-2021</u> Thursday
25-	The Secretary General will convene the first Meeting within Two days of newly elected Members of the Executive Committee for Election of the Office Bearers.	=	<u>16-09-2021</u> Thursday
